



COMMONWEALTH-AMDISA REGIONAL DOCTORAL AND POST-DOCTORAL PROGRAMME



The Governance and Institutional Development Division of the Commonwealth Secretariat has sponsored the above Fellowship Programme during 2003 to 2008.

The specific objective of the Programme has been to provide financial and academic-institutional assistance to South Asian Ph.D. scholars and younger employed academics with Ph.D. for undertaking internationally publishable quality research, based on original inter-country comparative studies in emerging areas of management and/or related social sciences and other disciplines. It has facilitated field work by selected Fellows in two to four regional countries.

The broader goal has been to contribute to the development of South Asian perspectives, networks and communities in management and related areas.

Under this Programme, eight Fellowships have been awarded, as shown in the Table below:

Review Articles on the completed Fellowship Studies by independent subject experts are being published in AMDISA Newsletter. It is planned to promote wider/international dissemination of the completed Fellowships' studies by bringing out suitable Working Papers based on these studies and compilations of the final studies, in due course of time.

The Programme has promoted further development of academic skills for Doctoral and Post Doctoral international comparative research in the selected Fellows. Through a network of AMDISA host and other academic institutions in the countries visited by the Fellows, it has also facilitated academic networking and cooperation among the various institutions.
